Accomplishments

Funding/State Recognition

- Awarded Sierra Nevada Conservancy IRWM Launch Grant of \$55,000 (2008)
- Recognized as an official IRWM region by Department of Water Resources through Region Acceptance Process (2009)
- Awarded Proposition 84 Round 1 Planning Grant of \$237,000 (2011)
- Awarded Prop. 84 Round 1 Implementation Grant of \$1,075,000 (2011) to fund seven on-theground water improvement projects (water supply reliability and water quality) and one feasibility study http://inyo-monowater.org/inyo-mono-irwm-plan-2/implementation/

- Awarded Prop. 84 Round 2 Planning Grant of \$480,000

 planning projects (stormwater and flood management)

- Awarded Prop. 84 2015 Round Implementation Grant of \$1.8 million (2015) to fund six projects, including a cashfor-grass water conservation project in Ridgecrest and a water quality treatment installation in June Lake https://inyo-monowater.org/our-work/implementation/
- Awarded Prop. 1 Disadvantaged Communities
 Involvement grant of \$463,000 (2018) to continue our
 work engaging DACs, tribes, and other

- Preliminarily awarded \$366,000 through the Prop. 1 Round 1 Implementation Grant (2020) for three construction projects in Crowley Lake, Big Pine, and Death Valley Junction
- In total, since 2008, \$5 million in grant money has been awarded to the region, the vast majority of which has remained in the region
- Inyo-Mono IRWM Program was represented on the California Water Plan Update 2013 Public Advisory Committee, Disadvantaged Communities Caucus, and North/South Lahontan Regional Fora
- Inyo-Mono IRWM Program was represented on the DWR Climate Change Technical Advisory Committee (2012 – 2014)
